## **Frequently Asked Questions**

- What is the program format? The program contains ten modules:
  - 1. Career development counseling and assessment
  - 2. Holland's RIASEC theory of personality types and work environments
  - 3. Components of the Strong Report and introduction to standard scores
  - 4. Scales, standard scores and administrative indexes
  - 5. The General Occupational Themes and the Basic Interest Scales
  - 6. The Personal Style Scales
  - 7. The Occupational Scales
  - 8. The Major Scales
  - 9. Unique Reports
  - 10. Scale inconsistencies, cross-cultural implications, and ethics

The program includes brief interactive assignments, a quiz at the end of each module, and a culminating interpretation activity.

- How long does it take to complete the program? The program is designed to take
  the same amount of time as our public programs, approximately 40-45 hours. It is
  self-paced. Some participants are able to complete it over a few weeks; others
  spread out the time in the entire time allotted.
- <u>Is there a deadline for completion?</u> You have 60 calendar days to complete the program from your chosen start date. We will automatically drop anyone who does not complete the ten quizzes and five assignments within 60 calendar days or who does not complete a quiz or assignment at least once every 14 calendar days. There is a fee to re-enroll.
- How much computer knowledge is necessary? You will be accessing the course on any web browser, clicking on links to access reading material, watching video presentations, submitting assignments in ordinary word processing via email to your instructor, and emailing back and forth with GS staff and instructors.
- How do I get feedback on my work? You will receive immediate feedback on your quizzes and you will receive feedback by email from your instructor as you submit your answers to the assignments.

- <u>Can I contact others in the program</u>? Since the program is an asynchronous one, there is no live, in-person interaction required. You will email back and forth with an assigned instructor throughout the span of your course, and be invited to join a LinkedIn group for certified practitioners after completion.
- How do I register?

- What is the cancellation and refund policy? Your program registration fee, less a \$200 administrative fee, will be refunded if written cancellation is received at least five (5) business days prior to your scheduled start date. Requests to delay within five (5) business days of a confirmed start date will require a \$75 administrative fee.
